

# 2024 Healthtech in Review



The decrease of funding across Africa from 2023 - 2024

In 2024, there was a **26% decrease** in capital raised from **\$4.3 billion** to **\$3.2 billion** 


Specifically, the health tech sector experienced a **sharper decline**, with investments dropping **from \$167 million** in 2023 to just **\$71.3 million** in 2024

There was also a **24% decrease** in **number of investors** in 2024 compared to 2023

Venture Rounds were the most common, accounting for over \$35 million across 22 startups, indicating robust investor confidence in scalable healthcare solutions




DEG (Germany) was notably active, funding 5 startups through grants, an indication of the significant role of international development funds in bolstering African healthcare innovations








### Funding raised between scale-ups vs start-ups



Scaleup Pain Points









# New partnerships forged

Helium Health, a leader in Electronic Medical Record (EMR) systems in Africa, & Signalytic, Africa's leading solution for providing critical infrastructure for digital healthcare tools announced a new partnership.



This collaboration combines
Helium Health's advanced EMR
systems with Signalytic's S+
Platform, which ensures not only
reliable power and connectivity
but also the seamless
deployment of software
to health facilities.



By addressing infrastructure challenges, Signalytic enables smooth, uninterrupted operations, allowing healthcare providers to focus on providing patient care while using Helium's software, and benefiting from real-time data access and Management.

The first landmark deployment will be rolled out across three states in Nigeria, enabling complete, sustainable digitization of 55 health facilities in Q4 2024 for the very first time. The partnership between Helium Health and Signalytic will look to jointly enter additional health facilities and scale up together in 2025.

Both companies are proud members of the 2024 cohort at the HealthTechHub, and were thrilled to unveil this partnership at the 2024 Health Tech Summit in Kigali.

This joint initiative marks a significant step toward expanding digital healthcare solutions across Africa, with the first deployment in Nigeria laying the groundwork for broader impact.













# Achievement of success

Each company shared their goals for 2024 at the beginning of the program. These included increasing revenue or investment funding, forging new partnerships, reaching new users and/or strengthening their organizations.

Of companies that achieved or exceeded their goals, most attributed the HealthTech Hub Africa Accelerator Program with high impact on their success.

Some companies did not achieve their goals because a strategic shift meant the goals were no longer relevant.



Percentage of innovators who achieved their 2024 goals






















# The 2024 Innovation Challenge

The 2024 Innovation Challenge deployed \$400,000 in grant capital to 7 startups seeking to demonstrate their solutions for new public sector use cases.



Startups from the 2022-2024 cohorts were invited to apply with solutions to improve the accessibility, quality and client-centeredness of health services.















## **HealthX Africa**

HealthX Africa is a direct-to-patient healthcare provider that leverages technology to make high quality primary health care and wellness accessible, affordable, convenient, and equal. The company is leveraging market-based digital solutions to improve access to quality PHC Networks in Kenya. Their key objective is to test a scalable model for integrating private, virtual PHC providers within PCNs in Murang'a County, Kenya



# Afya Intelligence

Afya Intelligence is a **Tanzanian** startup partnering with the Tanzanian MoH and InSupply Health, to assist local clinics in utilizing eLMIS data for precise forecasting. It provides automated data cleaning, Al-driven predictions, and visualizations for better decision-making ensuring accuracy. Together, they have developed a proof of concept for a Predictive Analytics Module (PAM) for Tanzania's eLMIS with potential to reduce forecasting time from 30 to 3 days for over 150 essential products.



### **Achievements by October 2024**



- 38 PCNs registered 15,000 patients including 2,300 chronic disease patients
- Establishment of virtual clinics in 3 facilities Kamacharia Dispensary, Kiriani Dispensary and Nyakianga Health Center

# **Aurora Health Systems**

Aurora Health is a **Kenyan** startup partnering with Benacare Ltd, MoH Kenya, and Kenya Renal Association, to digitize dialysis data across private and public healthcare sectors, ensuring shareability and adherence to HL7/FHIR standards for interoperability for improved access to renal care.



# **Emergency Response Africa**

ERA is a **Nigerian** startup partnering with Ogun State Primary Healthcare Development Board and Ogun State Ambulance and Emergency Services, to reduce preventable maternal & child mortality through technologyenabled dispatching of community first responders and emergency transport to get mothers and their babies to hospitals fast.



# MedTrack (\$50,000)

MedTrack is a comprehensive, interoperable, and patient-centric EHR platform that integrates with **Ghana**'s national biometric digital ID system to improve the quality and continuity of care. MedTrack is partnering with the Ghana Health Services through the Gomoa East District Health Directorate to deploy and refine MedTrack's platform across all 31 public health facilities in the district, serving a population of 32k+ people.



### **Achievements by October 2024**



- Held a CKD data tools workshop with multiple stakeholders
- Compiled data from CKD patients across 30+ facilities for analysis and standardization
- Contributed to the Renal Guidelines Development
   Workshop organized by the MoH and Kenya Red Cross
- Trained 30 community responders to identify maternal emergencies and provide basic responses including safe transport to nearest health facilities
- Registered 69 new pregnant women for their first ANC visits
- Facilitated 258 ANC related transports and provided emergency transport for 29 obstetric cases, directing 23 to primary and 6 to secondary health facilities
- Supported 18 live births via emergency transport and addressed 3 non-obstetric emergencies
- Partnered with Jangala to overcome connectivity barriers in underserved areas, enabling digital health adoption in Gomoa East
- Customized EHR platform tailored to Gomoa East District
- Selected as a 2024 AWS Health Equity Initiative (HEI) recipient, securing up to \$50,000 in cloud credits and technical support













## eFiche

E-Fiche is a **Rwandese** startup that transforms the last-mile healthcare by empowering providers and patients with digital tools and data insights for proactive care. E-fiche is pursuing potential partnerships with the Ministry of Health in Rwanda and Irembo



# **Helium Health**

Helium Health is a **Nigerian** startup that provides a suite of cutting-edge technology solutions for all healthcare stakeholders in emerging markets. The company has developed HeliumDoc AI which is evolving from a patient booking app into a patient-centered engagement solution. By integrating AI & algorithms, they focus on early detection of the HIV, TB, and diabetes in Nigeria.



### Achievements in first three months



- Developed an HMIS report loader within eFiche and collaborated with the MoH's planning and health financing departments to standardize key report indicators
- Trained **132 users** on eFiche's functionalities, emphasizing data privacy to prepare them for system rollout across the health post network
- Implemented and launched a ticketing feature in eFiche, enabling users to report issues categorized by priority level based on severity and urgency

- Held a co-creation workshop with 25 participants to gather feedback and refine the design of HeliumDoc AI
- Validated the risk stratification tool and got recommendations for improvement







# Investor circle

Startups often lack the right networks and information required to showcase their potential and fulfil investors, while investors face difficulties in sourcing a reliable stream of investable HealthTech ventures and ensuring their continuous development.

The investor circle aimed to bridge these gaps and foster a symbiotic relationship where start-ups get a wide network of potential investors, and investors gain access to a vetted, dynamic portfolio of innovative solutions with monitored growth trajectories.

The investor circle comprised three main pillars towards supporting start-ups and investors:

- Creating an investor database CRM (or a data room) with current or potential relationships to create and start-up matches to make.
- Enabling start-ups to pitch though the investor summit.

- The hub also held an investor summit which coincided with the Africa HealthTech Summit in Kigali in October 2024.























# 2024 HealthTech Policy Summit








# Regional SIL Capacity Building & Launch

Interoperability Lab (SIL) is an initiative led by HELINA aimed at improving healthcare across Africa through the use of open standards for interoperability of digital health systems. The SIL will champion the "full-STAC" approach—integrating open Standards, Technologies, Architectures, and Content—to drive digital health transformation.

- They also gained practical skills and strategic knowledge to enhance their contributions to national and global digital health ecosystems














# SIL Capacity Building Event @ Google

- Strengthened technical skills for implementing interoperable digital health solutions.
















